## Office of Student Enrollment- Sarah Kleinhandler and Jessica Shein

If you have more than one child the same age applying to HS (i.e., twins, triplets), you may choose to submit identical applications for each child so they receive an offer to the same program. 25 HS offers audition programs, they all (including LaGuardia HS) use the same common audition components for each discipline. Virtual auditions can be submitted on your My Schools Account.

Academically screened programs, students' best grades in four subjects - English, Math, Social Studies, and science- will be used from the final grades and/or form 8th grade final marking period grades. The best grades are assigned points and averaged to place students in one of four groups based on their point average. Students in group 1 are considered for offers before students from Group 2 and so on. If there are more applicants within the group than seats available, random selection will be used.

There are 20 academically screened schools that historically administered a school based assessment (e. essay, interview) these schools will continue to do so. School based assessments are evaluated at the school level

The health screener shares two functions: parents know they have the most information on who can and can't enter the school building. It is for responsibility, we hope that parents fill them out in good faith

We are really monitoring the hospitalizations.

The number only reflects the information that is provided to us. So, the numbers are shared daily, reflecting the information that is gathered from what is reported and inputted into the system whether it is a home test, school testing and parents reporting.
