#### **Smaller Class Sizes - Leonie Haimson**

Bill signed by the Governor on September 8th, 2022. The DOE has 5 years to phase in of smaller classes and this school year will be the planning year. It is a good thing and will take planning to implement class sizes to be capped at:

- 20 students grade k-3
- 23 students grade 4-8
- 25 students in high school
- 40 students in physical education and performing art classes

Each year starting Fall 2023 20% of all classes must achieve these caps with an additional 20% added each year, and a documented attainment caps due for September 2028. Prioritizing schools with high levels of poverty to reduce class sizes first. Two things are important to the long term implication for whether the city could be able to comply with the law:

- 1. A capital plan that provides the space necessary in our most overcrowded schools in our city. Even with the decline in enrollment 27% of NYC schools citywide were over 100% utilization 37% of elementary schools were overcrowded. SCA hasn't fully completed with the two laws local 167 and 168 that were passed in 2017 that was supposed to make seating more transparent and accountable and to facilitate findings new sites for schools
- 2. Admissions about screens and no screens. Admission should be made with the thought on how this law is going to be complied with because it will have a long term impact.

The small class size will create more diversity

Class size reduction plans should be scheduled by a taskforce with UFT, CSA, and the DOE taking the lead. It is important that all groups be represented (including parents and students) and give their input and to make sure that they provide expertise in these areas and that the impetus is there to show that this can actually happen.

The UFT and CSA have a letter that is signed to send to the DOE and we would like for you all to share and have other leaders sign on. links provided in the chat.

#### Black Edfluencers United (BE-U) - Dr. Django Blake, President

BE-U vision:

- 1. Serve black educators
- 2. Influence others
- 3. Impact black children.

Years ago, there was a gathering of black educators at BMCC the real focus was to look at what was happening in systemic racism within education looking at the disproportionality data and seeing how there is a high percentage of black boys in special education but a low number in those same black boys in gifted and talented programs.

The Gathering of Black Educators came together to lift up black boys and address the issues of black children, shared culture, and shared trauma. Uplift voices that have not been heard. We emerged as an organization with a vision with seven (7) agenda items to push the issue of equity of black students and black families.

Who we are: Educators, Parents, and Community Leaders.

BE-U is looking to develop relations with other organizations working in partnership in the educational

advocacy. Invitation to be a member of BE-U and have committees to further our agenda. Policy Advocacy Culture and Committee and Capacity is how BE-U develop educators and mind set readiness so that you can understand the communities that you are serving. Working presently on Black students curriculum and increasing the number of black educators.
