#### **Settle's Not So Secret Gems:**

CPAC's new agenda item to provide additional support, resources, and parent leadership knowledge for Presidents' Councils to support their PA/PTAs. This segment is led by CPAC's FACE Liaison, Anthony Settle. October's topic was Finances.

- Finance of Presidents' Councils and PA/PTAs:
  - **NO ONE** is exempt from the Chancellor's Regulations A660.
  - Financial regulations all can be found in CR A660.
  - Presidents' Councils can support their PA/PTAs by having conversations about finance, banking and money management and documentation (record keeping). Review the regulations on finance.
  - Support so one goes on the slippery slope of financial troubles and progress downhill.
  - Financial responsibility is solely on the presidents' council and PA/PTA; not the school, district, or FACE.
  - You must have your own EIN or Tax ID. You need this to open a bank account. <u>YOU CANNOT USE THE SCHOOL'S or DISTRICT's and you must have your OWN BANK ACCOUNT</u> not the schools, etc.
  - Shop for a bank. Make them work for your business.

OSE came briefly to speak on Middle School Enrollment which started yesterday. Mr. Broggini gave information and updates in regard to Middle School Enrollment. The Office of Student Enrollment will be back next month to discuss Admissions.

- ➤ Deadline registration for the SHSAT is October 27<sup>th.</sup>
- ➤ December 1<sup>st</sup> is the deadline for HS Application, LaGuardia HS application, and additional materials such as auditions, essays, etc. for screened schools with assessment programs.
- ➤ Deadline for Middle School application is December 8<sup>th</sup> and upload audition videos through My Schools.

#### Mosaic Curriculum & Black Studies – DC Carolyne Quintana & Team:

Deputy Commissioner of Learning and Teaching Carolyne Quintana gave an overview and updates of the great work that is happening in the Learning and Teaching division.

<u>Citywide Instructional Priority</u>: Every Child must have a high-quality academic experience that leads to deeper learning.

- Lever 1: Schools will facilitate mastery of core academic skills and show content expertise.
- Lever 2: Schools will facilitate pedagogy that prioritizes critical thinking and problem-solving skills.
- Lever 3: Schools will facilitate a sense of belonging and inclusivity for all learners.

QC Quintana introduced the Mosaic Curriculum and Black Studies teams trying to build an inclusive curriculum and CSRSE. Mosaic Curriculum is a passport to social studies and AP courses. The African American Studies is about cultural competence; students really understanding their own culture; and being able

to read write think and speak in ways that they understand. Plays of power and Equity and where there has been oppression and anti-oppression. So, students understand others culture.

To build an inclusive curriculum so that we teach kids about differing perspectives; we teach about honoring other strengths. We can build empathy and that we are following the framework of being culturally responsive, linguistically responsive, and we can help teachers reflect on even how their own identities and experiences impact how they show up and come into the classroom.

Present from the Mosaic Curriculum and Black Studies team are Hewlitte Moore, Deonca Renne, and Joe Tuft (leads the division of educator development).

#### Mosaic Curriculum – Chief of Staff Hewlitte Moore

- ➤ Mosaic NY at its Core 400 years of NYC History
- ➤ Hidden Voices Untold stories of NYC history. To affirm and amplify the diverse experiences of our students in New York City and they are unique to New York City.
- > Passport to Social Studies
- ➤ Support building civics knowledge with a comprehensive K-12 civics curriculum.
- > Implicit Bias training: Teacher training that is focused on culturally responsive and sustaining practices in the instructional materials that we put in front of our students.

#### Black Studies – Deonca Renee

- Distinction between the Black Studies curriculum work that has been launched by EAPC which is the Educational Equity Action Coalition group lobbied for the creation of a stand-alone black studies curriculum and recognize the importance of that work being accessible to all of our students. Entering year three, NYCPS have been working intentionally with EAPC to ensure that there is synergy between the lesson plans that they've created for the black studies curriculum and what does that mean and look like to be a part of the global Africa diaspora work that NYCPS already shaping. So, when this launches, as We Teach and as a tangible product for our schools. You'll be able to read and hear a little bit more about the alignment between the black studies curriculum and the global Africa work.
- AP African American Course work that is being piloted right now Across the Nation and NYCPS.
- The AP African American studies course is an interdisciplinary course that crosses into a variety of fields including Literature, the Arts and Humanities, science, geography, and political science.
- Explores the vital contributions of and experiences of African Americans.
- The course is fully aligned with the New York City Reads agenda and the three levers.
  - which is to facilitate Mastery of core academic skills and content expertise to facilitate pedagogy that prioritize critical thinking and problem solving skills.
  - facilitate a sense of belonging and inclusivity for all learners.
- Last year two New York City Public Schools participated in the in the year One Pilot and this year over 50 of our schools are participating in the second pilot.
- ➤ The first year there were no exams associated with this course but this year our students will participate in an exam that will happen in the spring of 2024.
- ➤ In the school year 2024 to 2025, the course will have its operational launch so it will no longer be in its pilot phase and any school will be able to participate.
- ➤ We are at this point in the process where over 200 colleges and universities have already committed to supporting this course through credit and advance placement.

# **NYC Chancellor David C. Banks:**
