# FACE Updates

Cristina Melendez, EdD, Executive Director FACE <u>cmelendez15@schools.nyc.gov</u> Joined by Jesse Mojica, Deputy Executive Director FACE <u>jmojica@schools.nyc.gov</u>

- Melendez greeted CPAC and offered words of appreciation and well wishes in advance of Mother's Day
- Melendez noted that FACE is finalizing the draft updates to CR A-655 Once complete, the process of updating CR A-660 will begin
- Melendez shared that FACE is going to assemble an election working group additional information will be shared at another time
- As mentioned last month, FACE will host NYCReads events the next Big Book Party will be in Queens on May 19<sup>th</sup>
- Mojica shared information about upcoming workshops and highlighted their continued work with the Commission on Human Rights upcoming workshop schedule:
  - May 13<sup>th</sup>: Rights and protections under the law for Transgender and Gender Non-Conforming people
  - May 21<sup>st</sup>: Bias awareness
  - May 22<sup>nd</sup>: Parliamentary procedures
  - June 5<sup>th</sup>: Bias awareness
  - June 11<sup>th</sup>: Parliamentary procedures
- Mojica also shared information about upcoming year-end Town Halls with Chancellor Banks
  - May 20<sup>th</sup>: CC D75
  - May 30<sup>th</sup>: CEC 23
  - June 11<sup>th</sup>: CEC 11

# **Division of Instructional & Information Technology (DIIT)**

Helen Barahall, Chief of Staff, DIIT <u>hbarahal@schools.nyc.gov</u> Joined by AnnMarie Dull, Senior Advisor, DIIT <u>adull@schools.nyc.gov</u>

- Barahal shared greetings from DIIT with CPAC and explained that her partner, Dull, would share updates
- Dull shared information about resources and supports that should be shared with parents and families via parent leader email including:
  - Public-facing two-part webpage on InfoHub for all parent leaders
    - #1 is account overview, details, and provided resources
    - #2 is WIP "how-to" page
  - As of right now, only basic information has been posted
- Dull noted that DIIT plans to conduct thorough training for district Family Leadership Coordinators (FLC) and Family Support Coordinators (FSC)
  - Note: All training sessions will be recorded
- Dull shared that DIIT has welcomed and received tons of feedback and instead of putting together a series of FAQs they responded by creating scenario specific micro-guides
- Dull shared InfoHub links in the chat and explained that these will be treated as "living resources" that will be updated frequently by DIIT
- Co-Chair Garay asked a question regarding disclosure of personally identifiable information (PII) and noted that any *requirement* of PII may violate CR A-660

Note: Garay noted that this question was first asked a month ago and there has yet to be any resolution

• Garay requested an update on the status of specific requests made by CPAC multiple times throughout SY 2023-24, including:

- Shared inboxes for parent leadership associations, councils, etc.
- Zoom accounts tied to shared inboxes
- Separation of accounts for parents in leadership positions across multiple associations
- Creation of email accounts for Title I parent leaders
- Shared inboxes for Title I parent leaders
- Given the general lack of movement on any of these requests, Garay reiterated CPACs request that DIIT pause their roll out until next year as doing so in a piecemeal fashion will create unnecessary confusion
- Barahal thanked Garay and CPAC for the feedback and continued partnership and explained that they would circle back internally
- Barahal explained that shared inboxes are still WIP and on the timeline for Fall 2024
- Barahal addressed the Zoom-related requests and noted that DIIT is working with Zoom's technical teams to find a solution
- Co-Chair Aubin asked two related questions and a question from the chat regarding the latest data breach
- CPAC engaged in discussion about cybersecurity

## How Does the SCA Get Their Numbers for the Blue Book?

Nina Kubota, President & CEO, NYC School Construction Authority (SCA) <u>nkubota@nycsca.org</u> Joined by Cora Liu, Director of Operations, SCA

- Kubota thanked CPAC for inviting SCA back
- Kubota and Liu shared a presentation and explained how SCA gets the data published in the "Blue Book"
- Kubota noted the Blue Book is published annually and reports enrollment capacity and utilization of all NYCPS school buildings based on the "Principal Annual Space Survey" (PASS) Note: PASS reports utilization of each classroom or each room in the building
- Kubota noted that the PASS is a longstanding process
- Kubota shared a number of changes in the last 10 years to SCAs formulas and reporting including:
- Transportable classroom units (trailers)
- Cluster rooms (specialty instruction rooms)
- Room dimensions (square footage calculations)
- Kubota explained that additional considerations were taken in the 2021 report following the class size law, including:
  - Reissuance of the 2020 Blue Book (with 2019 data)
    Note: Prior-year data was used because Covid-19 prevented SCAs annual survey of buildings
  - Lowering of class size targets
  - Discussion of "program efficiency" with Class Size Working Group (CSWG)
- Kubota noted that while the Blue Book is an evolving document, its purpose it to apply the same formula across all schools in the SCA portfolio
- Kubota explained that capacity formulas and calculations vary only by school level and remain consistent across all schools
- Kubota further explained that SCAs calculations are <u>not</u> intended to reflect actual programming and are used as a baseline for further analysis
- Kubota noted that this data is shared with district planning and others at NYCPS
- Liu took CPAC through an exercise illustrating how *capacity* is derived See here: <u>https://www.youtube.com/live/LiQ2QWywtTs?si=We5cG-et8\_ADay9s&t=3881</u>)
- Liu shared that this information is public and is published to SCAs website (https://nycsca.org)
- Liu answered a number of questions from the chat

- Kubota and Liu answered a question regarding the PASS and future working groups
- Co-Chair Aubin suggested SCA be in contact with other concerned stakeholders at the school level and reminded CPAC to begin engaging in these conversations with their SLTs to provide additional input for principals before they submit the PASS

# NYS Class Size Mandates & NYCPS

Dan Weisberg, First Deputy Chancellor dweisberg2@schools.nyc.gov

- First Deputy Chancellor Weisberg provided a summary of updates (below) and will present this topic in June
  - NYS certified compliance of year-one mandated reduction in 20% of classes
  - NYCPS is confident they'll meet the 40% reduction in year-two
  - State budget and required funding commitments
- Vadehra shared state budget updates and details about current plans to reduce class size including a proposed 3% reduction at the district level

#### NYCPS Chancellor David C. Banks (updates presented by First Deputy Chancellor, Dan Weisberg)

Joined by members of the Chancellors cabinet

• Co-chair Aubin shared questions regarding space for D75 programs, special education, support services therapy spaces, etc.

Cora Liu from SCA returned to address these

- First Deputy Chancellor Weisberg answered a question regarding mounting tensions across parent leadership spaces
- Deputy Chancellor Lloyd shared well wishes in advance of Mother's Day and added to comments made by Weisberg
- Co-Chair Aubin noted that while this conversation is largely happening in the C/CEC space, CPAC represents PA/PTAs and Presidents' Councils that are not subject to Open Meetings Law (OML) *Note: This necessitates a different approach from FACE and NYCPS*
- Melendez shared that all of the FACE team shares an awareness and understanding of what Aubin is alluding to
- Melendez noted that PA/PTAs and Presidents' Councils are autonomous

# "The Sun Rise in the East" School Curriculum

Presented by Cynthia Gordy Giwa and Taiyo Giwa, Documentarians

- The Sun Rises in the East is a documentary about a pan-Africa organization called The East *See here: <u>https://www.sunrisesintheeast.com/watch-the-trailer</u>*
- This documentary provides an opportunity for rich discussion in NYCPS about the triumphs and ongoing struggles faced by the Black community
- The Giwa's answered a question regarding streaming and encouraged anyone who is interested to stream the documentary where available (i.e., Amazon, YouTube TV) and noted that there is a discussion guide

- Settle noted that it is critical that sensitive account information like email passwords, login details, subscription details, etc. is shared
- Settle shared additional information regarding banking and account details
- Settle noted that the June Transfer of Records must take place by June 30<sup>th</sup> or the last day of the school year
- Settle and Co-Chair Aubin thoroughly answered questions from the chat and from membership
