Division of Early Childhood Education (DECE)

Simone Hawkins, Deputy Chancellor, Division of Early Childhood Education shawkins15@schools.nyc.gov

- Deputy Chancellor Hawkins greeted CPAC and offered to share her vision, future initiatives, and goals, including:
 - Optimization of seat placement to improve equitable access to programs
 - Stabilization via financial integrity and support to providers
 - o Deeper family and community engagement in a culturally responsive manner
 - o Redefining "high-quality" child development and learning environments
 - o Establishment of new leadership coach model to support schools and providers
- Hawkins highlights increases in 3K capacity (~15%), total enrollment (~114K), and special education seats
- Hawkins outlined NYC Reads' developmental screener and curriculum implementation

FACE Updates

- Mojica and Melendez opened with greetings to CPAC and shared words of appreciation and well wishes for Anthony Settle, retiring on 1 October after 20 years with NYCPS
- Mojica provided the following updates:
- o Upcoming Citywide Council on High Schools (CCHS) townhall with Chancellor Banks (19 September)
- o Presentations at various borough board and cabinet meetings continue
- Meetings with Parent Coordinator Advisory Council continue
- o Upcoming resource fair at Murry Bergtraum HS on 16 November
- Mojica highlighted summer literacy hub events and noted upcoming community festivals

NYCPS Chancellor David C. Banks

Joined by members of the Chancellors cabinet

- Chancellor Banks greeted CPAC and briefly addressed the ongoing investigation, stating that though his
 home was searched, and his phones seized, he is not a target
- Banks shared that NYC Reads curriculum is now implemented across all 32 districts
 - NYCPS expects reading scores to steadily increase over the coming years

- Banks addressed cell phone related concerns noting that over 350 NYCPS schools have cell phone restrictions in place with another ~500 planning to implement restrictions this year
- Banks noted that while NYCPS are encouraged to enact school-based policies regarding the restriction of cell phone use to reduce in-class distractions a full system-wide ban is still under consideration (pending further study)

- Barahall introduced Demond Waters, the Chief Information Security Officer for DIIT with Waters presenting
- Waters explained the difference between cyber-attacks attempting data theft and an actual data breach
- Waters outlined NYCPS' process for vetting vendor security and compliance
- Waters discussed protections like data encryption, ID verification, network monitoring, etc. and provided cybersecurity tips for families navigating the NYCPS website
- Waters closed by highlighting that October is National Cybersecurity Awareness Month
