

NYS Grades 3-8 Tests ELA, Math, & Science

Overview

The annual ELA and mathematics will be administered to all students in grade 3 through 8 later this spring. Students in grade 5 through 8 will also sit for the New York State science test. These tests are required by the federal every student succeeds act and are designed to provide important information about whether students are prepared to progress through school and graduate with the critical thinking, problem solving, and reasoning skills they need for longterm success in school, college, and careers, and to support students in their pursuit of economic security and a choice-filled life.

These tests are just one of several measures our schools used to assess students' progress: grades, report cards, writing samples, projects, assignments, and other performance-based student work are equally important.

Transition to Computer-Based Tests (CBT)

In spring 2024, approximately 138,000 students tested online for ELA, and 109,000 students in Math.

This spring, the estimated number of students testing online is 263,000 for ELA and 237,000 for ELA Math.

Spring 2025 Test Dates

ELA CBT: April 22 - May 2 Paper Test: April 29 - April 30 Make-ups: May 1 - 6

Math CBT: May 6 - 16 Paper Test: May 7 - 8 Make-ups: May 9 - 14

Science CBT: May 13 - 16

Test Design

The ELA and Math test consists of two untimed sessions and are administered over 2 days (one session per day).

- Session one and two for ELA include multiple choice and open-ended questions.
- Session one for math is multiple choice only. Session 2 for math includes multiple choice and open-ended questions.
- The science test, administered only in grade 5 and 8, is a single session that includes multiple choice and open-ended questions.
- All three tests are untimed. Students who need more time will be able to work at their own pace to better demonstrate what they know and can do.

Exemptions

All students enrolled in grades 3 through 8 are expected to participate in state tests as part of the core academic program. However, there are the following exemptions:

- Accelerated mathematics students taking regents examinations
- Accelerated science students taking regents examinations
- First year ELL students (ELA only)
- Students that take the New York State Accelerated Assessment (NYSAA)
- Medically excused students

Accommodation

In general, students must be provided with testing accommodations specified in their IEPs or 504 plans when taking these tests.

This accommodation could include, but are not limited to:

- Flexibility and Scheduling (examples include providing frequent breaks)
- Flexibility in Setting (examples separate room or locations)
- Method of Presentation

ELLs and former ELLs can be provided with the following accommodations:

- Separate location
- Alternate language editions math and science
- Bilingual dictionaries and glossaries
- Oral translation for lower-incidence languages math and science
- Writing responses in home language math and science

Benefits

- Provide detailed information about whether your child is learning what is expected of them for their grade levels.
- Help schools determine how students are progressing and performing compared to their peers, and which students or teachers may need more support.
- Allow you to learn how your child's school is doing compared to other schools.

Participation

- NYCPS strongly encourages all students to take these tests because both parents and students benefit from the information we learn through test results. State tests provide additional information on what each child is learning and help teachers and schools adjust support where needed.
- If parents are interested in opting their child out of state tests, they should consult with their child's principal. If, after consulting with the principal, they still want to opt a child out of the exams, the principal will respect their decision. The parent and the principal should maintain a written record of this conversation.
