Children have an admissions priority to...

Families can learn which priority groups received offers last year on MySchools!

- They're zoned school
- Most families have a zoned school
- Most NYC children attend their zoned school for kindergarten
- Not all zone schools offer 3-K or Pre-K
- Schooors in their school district
- The school where their sibling is currently enrolled
- The school where they are a current student
- G & t program give priority to siblings and families who reside in the district

Families can list as many choices of interest.

The best strategy is to list choices in true preference order.

- This means listing the top choice as the number one on the application etc
- How choices are listed on the application does not change a child's priority at any given school

- For example, if you're a current student at a school listed on your application, you will always have the priority no matter where you list it on the application
- If there are two or more programs at a school, families can apply to both, or one or the other
- Families should only list schools they want their child to attend, and should not include choices they are interested in.

For children born in 2020, 2021 and 2022

- Children born in 2022 are eligible to enter 3K, and those born in 2021 are eligible to enter Pre-K beginning fall 2025
- Both applications will open on January 15th
- Children born anytime in 2020 are eligible to enter kindergarten in the fall of 2025
- The kindergarten application is now open! The deadline to apply is January 24th
- All applications submitted by the deadline are processed as one-time applications the admissions process is not first come first serve
- Families can list as many choices as they would like on their application we recommend only applying to programs you would like your child to attend
- Find your school district by entering your address at schoolsearch.schools.nyc or by calling 311

For children born in 2020

Gifted and Talented Programs:

Reminder that families can apply to both general kindergarten and kindergarten gifted and talented programs using this application. If a family is interested in GNT programs, they should be sure to list programs in their true order of preference.

Eligibility:

Current Pre-K students at NYC public schools District schools, Pre-K centers, NYC Early Education centers, or charter schools are evaluated by their current Pre-K teachers after they apply.

Current Pre-K students at private or parochial school programs, or for children who are not yet in school will be contacted by the division of early childhood education to set up interviews that will determine eligibility after they apply.

Fifth Presentation Class Size Law by Chief Operating Officer Emma Vadhera

Class Size Implementation

What is the class size law?

Requires that NYCPS reduce actual class sizes (not average).

Reductions must begin in school year 2023 to 2024 year one, with 20% of classes in compliance; threshold increases by 20% each school year to reach 100% compliance by school year 2027 to 2028

Exemptions:

The law allows four types of exemptions to the class size targets

- With capital budget aligned to resolve
- Over enrolled students
- License area shortages
- Severe economic distress

Any exemptions must be approved by the UFT and CSA. School Year 2024 to 2025 Class Size Reduction Plan and Policies in

- Requiring all districts to increase compliance by 3%, to ensure principles are making progress on class size, along with a non-exhaustive list of strategies that schools may undertake to reduce class sizes
- Updated Capital planning strategy, to ensure the \$27,000 seats from the prior capital plan work to alleviate class size and to focus seats already underway and identify new needs so that we can appropriately assign allocated capital dollars to districts that need seats
